- 4) The Application form should be recommended by the State Council.
- 5) Please note that the form should be filled either in Hindi or English. Any document/information provided in any regional language should be accompanied by a translation in Hindi or English.
- 6) This form should be accompanied by i) copy of latest school progress report of the applicant
ii) Authenticated Income certificate of the family of the applicant certifying the total monthly income from all sources.
- 7) Disability certificate in case of disabled children.
- 8) Incomplete application not accompanied by necessary documents will not be entertained.
- 9) Only one child from a family is eligible to get the Sponsorship assistance.
